# 1 DIRECTORS' REPORT

In compliance with the EOTAS foundation constitution and the Tanzanian financial Accounting Standard nr. 12 on Directors' Report, the directors are pleased to submit the report, auditor's report and audited financial statements of EOTAS for the year ended 31<sup>st</sup> December 2014.

The year 2014 has been used by the EOTAS Foundation to further improve and expand activities in Tanzania in order to assure sustainability of the deaf school and associated programs in Dodoma. EOTAS remains committed to empowering deaf children to build a life of dignity and self-reliance in the future for themselves. The program operates in accordance to various international human rights treaties and millennium goals, ratified by Tanzania, which specifies the right of good education for all children.

The Dodoma Deaf School continues to be the pivot point of the Deaf Education Program in Tanzania. With the school as the centre of activities, other programs are implemented around it in line with available resource, required for each program. Furthermore a strategy is under development to make the school self-reliant in the future, whereby only Government support and Income Generating Activities will have to fulfil all the requirements of the school and associated programs. This strategy will take some time to develop and will be adjusted according to prevailing circumstances in Tanzania.

This annual report discusses the following six main activities during the year 2014:

- 1) Support to the Dodoma Deaf School,
- 2) Cooperation with other organisations,
- 3) Partnership developments with DCT
- 4) Income Generating Projects and Vocational Training,
- 5) Construction activities.
- 6) Supplementary Services.

## 2 Support to the Dodoma Deaf School

The Dodoma Deaf School started 2014 with 2 groups in preschool and 9 groups in Primary Education. Children in preschool level may continue there for one or two years depending on their personal progress. According to government regulation the primary school classes are divided as follows: 1a, 1b, 2, 3a, 3b, 4, 5a, 5b, 6, 7. This system results in a total of 10 years of primary school education for deaf children as opposed to 7 years for regular primary education. The extra years were put in place to give the deaf children more opportunity to take in the information presented during the lessons. The running of the school and well-being of the children is further strengthened by the following staff:

- Two office girls;
- Three cooks at school;
- One patron and one matron;
- Two maintenance people;
- Five guards;
- One housekeeper at Camp Holland
- One school manager
- One Program Director.

Due to shortage of buildings has the school decided to combine groups in the same classrooms. In addition the school is using three of the boarding houses as temporary classrooms for primary education. EOTAS provides the following assistance together with The Liliane Foundation from the Netherlands:

- Travel support for pupils and their parents, when required.
- Payment of allowances for assistant teachers.
- Medical care including hospital visits for the children.
- Provision of tea, porridge and small snacks during mid-morning break.
- Funding of boarding facilities and caretakers for 62 children, who failed to go home daily due to distance or domestic problems.

As a result of the assistance of EOTAS the school continues to expand. Still the school faces many challenges as follows:

- Shortage of 6 classrooms during the year 2014.
- Insufficient funds to take care of more children in boarding. Many deaf children are denied their right to receive good care and an education, because of distance and/or problems at home.
- Shortage of sufficiently trained teachers who are capable of using sign language to support the children in communication, in their whole social- and learning development and understand the psychological needs of deaf children.
- By the end of the year 83 children were registered at the school. In reality an average of 74 children would show up daily. Often different parents find the challenges of daily survival to great to assure that their children attend school every day. Few parents give the education of their deaf child the importance it requires. This is one of the reasons why participation in sign language training and close contact with the school is hard to realise amongst all parents.

### **3 Cooperation with other organisations**

- EOTAS acts as a mediator for the Liliane Foundation from the Netherlands to assure that deaf children are given the opportunity to attend school and stay in boarding when required, due to distance or other issues at home. Thanks to this cooperation, 82 children have received direct sponsorships and as a result they were able to attend school daily.
- EOTAS works together with the Anglican Church in Dodoma (DCT) and the Municipality of Dodoma in the management of the Dodoma Deaf School. The organisation provides funding, management coaching, and financial and administrative support. The DCT takes responsibility for daily management of the school and the boarding facility. The Dodoma municipality is responsible for providing salaries of trained teachers and basic food for the children in boarding.
- On a nationwide approach EOTAS works together with Global Deaf Connection/USAID from America in developing a teacher training program for deaf students. Under this program deaf Secondary graduates will be given the opportunity to enter teacher training college and become teachers for deaf primary education pupils. EOTAS assists with financial management, networking and office facilities.
- Further cooperation continues with the Special Education Unit at the Ministry of Education in Dar Es Salaam on selection of suitable teachers for the Dodoma Deaf School and planning expansion of the school and the deaf education program.
- Wanaziwi Foundation from the Netherlands manages the Art and Craft training Centre in collaboration with EOTAS Foundation. The Centre experienced some delays due to the heavy workload of key-personnel. It is expected that in the coming year children will be offered the opportunity to start learning the basics in tailoring and use of sewing machine. The Centre will also continue to make products as Income Generating Training Activities. Revenue from sales of products will be used to support the tailoring training program.
- Shuleni Foundation from the Netherlands provides expertise and financial support on an individual child basis, thus enabling EOTAS to improve specifically pre-primary education.

### **4 Partnership development with DCT**

As reported in previous Annual Reports, EOTAS has been exploring possibilities of finding a suitable partner to take over the Dodoma Deaf School in the future. In 2010 a tentative agreement of transfer was reached and signed with the Anglican Church in Dodoma (DCT). To make this agreement valid, there are several procedures to be followed and agreements to be reached on correct use of property and other resources to assure the school will continue to perform well.

This process requires first obtaining all the appropriate documentation on legal ownership and sponsored construction and acquisition of property. Furthermore an appropriate Memorandum Of Understanding needs to be agreed upon, which will document all the details of the school management. Upon completion of these procedures the transfer of property can be realised including value, appropriation of property and time frame of the actual transfer. During this process DCT will remain the preferred institution to take over the Dodoma Deaf School and supporting Income Generating Activities, in case the organisation ceases to work in Tanzania.

## **5 Income Generating Projects and Vocational Training**

Many deaf youths fail to continue in Secondary education after finishing primary education. The provision of practical skills through recognized Vocational training institutes offers a solution to some of the deaf youths. EOTAS supports deaf youths who show a high level of motivation and hard work to succeed at their studies. Currently EOTAS works together with Wanaziwi Foundation from the Netherlands in setting up a tailoring project for deaf women. The project is carried out in the Wanaziwi Tailoring Centre on the school grounds of the Dodoma Deaf School. The project experienced several delays due to the heavy workload of key-personnel and other circumstances beyond our control. As result of a training program carried out by Hennie Hoek in November the tailoring activities are now well organised and are expected to be expanded and improved during 2015.

The practical training facility, which is expected to facilitate training in carpentry, mechanics, electrical and plumbing is still under construction. Due to various circumstances outside of the organisation's control, there have been significant delays with the construction. However in 2014 construction has progressed again in big steps and an effort will be made to complete this project at earliest possible opportunity.

In general the policy is that once deaf students have finished their studies successfully they may apply for a position within the school or in any other organisation or business. It falls outside the scope of EOTAS to guarantee students work, but the organisation will assist as a mediator between potential employers and a deaf candidate. If the school needs assistance, then a deaf person, who has finished his/her studies successfully, may be required to work at the school under normal employment conditions.

## **6 Supplementary Services**

In addition to facilitating education for deaf children, EOTAS aims to improve and expand provision of Audiometry, Otoscopy, Hearing Aid Fitting and Counselling for parents. These activities are aimed to improve the communication of the children with their environment.

The audiometry and hearing aid program has been in existence for several years, but currently needs suitable personnel to improve and expand it further to reach the desired quantitative and qualitative level to be as effective as envisaged. The process of finding the right people who can manage this program without supervision proves to be challenging and is still ongoing. Currently children are assisted with hearing aids from the Netherlands with support from Nienke Munting and "Beter Horen", until a more permanent and sustainable solution can be found.

## **7 Support Activities and main events**

During the year 2014 EOTAS carried out the following activities:

- The eight rental apartments in Kilimani have become an important part of financial support for the school. Although occupation of the apartments was lower than expected, the apartments still managed to contribute approximately 16.4% to the EOTAS share of expenses of the running cost of the school.
- In October 2013 the school received two volunteers (Lonneke and Amy) who helped the children with many learning activities. In January 2014, one of the volunteers, Lonneke van Bladel returned to the school for 3 months to continue with her assistance of the deaf Children.
- Construction of the practical training facility continued in the period of June to September 2014 and walls were completed and roof and windows were installed. The facility still needs a concrete

floor, equipment and wall plastering. However it can be used for ongoing technical work and some practical exercises. Work continues in accordance with available funds

- In July 2014 Monique and Isabel from Shuleni (NL) came to the school to advise on Montessori teaching practices and assist with making photos for sponsoring purposes.
- In August 2014 the school received a group of volunteers from the Netherlands, who helped with the construction of the playground for the young children.
- The Wanaziwi tailoring studio has been completed in October 2014, prior to an intensive training program carried out by Hennie Hoek from the Netherlands under the Wanaziwi program in November.
- In November 2014 Gerard Pape from the Netherlands trained some of the children in basic mechanics at our training facility.
- In November 2014 Nora and Nikki helped out at the school with improvements and modifications of the playground, to make it safer and more suitable to the children at school.
- The school also received support from Menonite Church Community (MCC) with setting up an Agriculture project with chicken farming and growing vegetables on the school grounds.
- The Government of Tanzania helps the school with regular health check and inoculation programs for the children.
- Throughout the year EOTAS has many more support and implementation activities to assure improvement and expansion of the Dodoma Deaf School. More information on these activities is also available in the periodic newsletters.

## **8 Result of the objectives set for 2014**

The priorities of EOTAS are determined by the needs of deaf children, their parents, the school and general cooperation of authorities. This means that from time to time short term targets will be adjusted due to new urgent needs arising or change of general policies. The following objectives have been achieved in 2014:

- Due to unfortunate and untimely death of the Bishop of the Anglican Church, Bishop Ndimi, the church has been pre-occupied with re-organisation and no further developments can be reported on the proposed transfer of the Deaf School, responsibilities and property to the Anglican Church.
- Training of teachers in sign language and deaf education continues, but proves a difficult job in Tanzania, due to challenging work conditions, work attitudes and general policies from local authorities.
- The playground has been constructed in July 2014. There is still room for further improvement and expansion, which will take place in due time when there are funds available for these activities.
- The practicals training facility has moved ahead thanks to some funding through connections of Shuleni (NL). The roof, windows and doors have been installed and the building can be locked up when so required.
- The school has now 13 government teachers and continues to negotiate for additional teachers in order to keep up with the growing need of education for deaf children at the school.
- Construction of additional buildings of the proposed Vocational training Centre has not developed further during 2014 due to lack of funding.

## **9 Objectives for 2015**

The priorities of EOTAS are determined by the needs of deaf children, their parents, the school and general cooperation of authorities. This means that from time to time short term targets will be adjusted due to new urgent needs arising or change of general policies. The following objectives are set for 2015:

- EOTAS and the Diocese of Central Tanganyika will further investigate the possibilities of the proposed transfer of the Dodoma Deaf School and all property. During this process the interest of education for the Deaf Children and sustainability of the Dodoma Deaf School remains the main focus point.
- Negotiations with the government must lead to further improvement of support for the education of children at the Deaf School. This is challenging process, as the education of deaf children is not seen as a priority by authorities. Nevertheless it is expected that we do make progress in due time and that more responsibilities are carried by the Tanzania Government.
- Continued training of all teachers to become measurably better skilled and confident in using sign language at school.
- Further construction and utilization of the practical vocational training centre. We aim to lay the floor, finish plastering, build an instruction room and obtain tools and equipment.
- Appointment of sufficient qualified deaf teachers for all the classrooms. The school needs an additional 2 teachers for 2015.
- Construction of small boarding facility for the proposed Vocational training Centre, specifically for children who have need to stay at school in order to follow a vocational training program.
- Construction of buildings for the Primary school with initial focus on the dining room. Administration building and classroom. This project received funding from the Liliane foundation specifically for these building projects.
- Development of Individual Vocational Training Manuals, for individualized training of deaf children, so they can learn at their own pace. This project received funding from the Liliane foundation specifically for these training projects.

## 10 Statement of responsibilities.

The following financial report explains the general income, expenses and balance of EOTAS in Tanzania. Insurance, airfares and allowances for the program coordinator are paid by EOTAS in the Netherlands and do not burden the Tanzanian organisation. All Board members of EOTAS are volunteers and do not receive a regular allowance for their position. They do receive a travel and food allowance when they attend periodic meetings.

The Board members are responsible for preparing the annual report and the financial statements in accordance with applicable law in Tanzania and Generally Accepted Accounting Practice. The NGO Act No. 24/2002- section 2 of Tanzania requires the NGO to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the NGO.

Reconciliation of all outstanding loan accounts causes a larger than usual re-adjustment in the financial report. The small loans occurred over a period of several years and repayments were intermingled with other activities. This issue has been corrected and due to improved strategies will not occur again.

In preparing those financial statements the Board is required to:

- Select suitable accounting policies and apply them consistently;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable accounting standards have been followed;
- Prepare the financial statements on the going concern basis, unless it is inappropriate to presume that the group will continue in business.



In accordance with the NGO act No 24/2002, as the Board members of the NGO, we certify that:



### 17.1 Note 1 - ACCOUNTING POLICIES

#### Funding policies:

- EOTAS-Tz seeks, receives and manages funds from donors, on behalf of the Dodoma Deaf School and post-primary deaf students.
- EOTAS makes all payments on behalf of Post-Primary Students.
- EOTAS receives income from donors in the form of grants.

#### Ownership and management of property:

Property acquired by EOTAS-Tz for the purpose of supporting Deaf Education in Dodoma continues to be managed by the organisation during the running of the project. All property are considered to be entrusted to DCT for the purpose of improving and expanding Deaf Education in Dodoma region.

#### Fixed assets:

Rates of depreciation used in the accounts for fixed assets are:

- Computers and printers 20%
- Furniture 10%
- Motor vehicle 50%
- Motor bike 25%

Depreciation is charged in full in the year of purchase.

#### The School Management:

- The school is managed by the Head teacher under the School Committee comprising of representatives from DCT, Teachers and parents.
- Financial resources for running and expansion of the school are availed through EOTAS Foundation.
